Titan Medical Continues to Market Offering of Units

TORONTO--(BUSINESS WIRE)--September 24, 2019--Titan Medical Inc. (“Titan” or the “Company”) (TSX:TMD) (Nasdaq:TMDI), a medical device company focused on the design, development and commercialization of a robotic surgical system for application in minimally invasive surgery (“MIS”), announced Monday, September 23, 2019 that it had filed and been receipted for a preliminary short form prospectus (the “Preliminary Prospectus”) with securities regulators in the provinces of Ontario, British Columbia and Alberta. Titan had also filed a corresponding registration statement on Form F-10 (the “Registration Statement”) with the United States Securities and Exchange Commission under the U.S.-Canada Multijurisdictional Disclosure System.

Further to last night’s press release, the Company has switched from an overnight marketed offering to a fully marketed offering. In consultation with its financial advisors, the Company expects to price the offering no later than September 27, 2019. The Preliminary Prospectus has been filed on SEDAR and the Registration Statement has been filed on www.sec.gov.

Pursuant to the terms set forth in the Preliminary Prospectus and the Registration Statement, it is expected that closing of the Offering will occur on or about October 8, 2019, or such other date or dates as the Company and the agent may agree.

About Titan

Titan Medical Inc. is focused on computer-assisted robotic surgical technologies for application in MIS. The Company is developing a single-port robotic surgical system comprised of a surgeon-controlled patient cart that includes a dual-view camera system with 3D and 2D high-definition vision options and multi-articulating instruments for performing MIS procedures, and a surgeon workstation that provides an advanced ergonomic interface to the patient cart and a 3D endoscopic view inside the patient’s body. Titan intends to initially pursue gynecologic surgical indications for use of its single-port robotic surgical system.
